BY-LAW No. 47-2012

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to make changes to the size of various Business Improvement Area Boards of Management.

WHEREAS Chapter 19, Business Improvement Areas, of the City of Toronto Municipal Code designates various areas of the City as Business Improvement Areas; and

WHEREAS Toronto and East York Community Council, under delegated authority, has approved the removal of some members from some Boards of Management, and the appointment of members to various Business Improvement Area Boards of Management, for a term expiring on November 30, 2014, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to reflect the change in the number of members and the number required for quorum of the various Business Improvement Area Boards of Management;

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. The table in Schedule A of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - (1) by changing the number of members of the Bloor Annex Business Improvement Area Board of Management to 10;
 - (2) by changing the number of members of the Chinatown Business Improvement Area required for quorum to 8;
 - (3) by changing the number of members of the Church Wellesley Business Improvement Area Board of Management to 17 and the number required for quorum to 7;
 - (4) by changing the number of members of the Danforth Mosaic Business Improvement Area Board of Management to 10;
 - (5) by changing the number of members of the Danforth Village Business Improvement Area Board of Management to 11;
 - (6) by changing the number of members of the Gerrard India Bazaar Business Improvement Area Board of Management to 16;
 - (7) by changing the number of members of the Harbord Street Business Improvement Area Board of Management to 7;

- (8) by changing the number of members of the Liberty Village Business Improvement Area Board of Management to 22;
- (9) by changing the number of members of the Mount Pleasant Business Improvement Area Board of Management to 6;
- (10) by changing the number of members of the St. Lawrence Market Neighbourhood Business Improvement Area Board of Management to 17 and the number required for quorum to 9; and
- (11) by changing the number of members of the Wychwood Heights Business Improvement Area Board of Management to 6.
