BY-LAW No. 71-2012

To amend By-law No. 2958-94 of the former City of York, being a By-law "To regulate traffic on City of York Roads", regarding Raglan Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. That Schedule X (Parking for Restricted Periods) of former City of York By-law No. 2958-94, as amended, be further amended by deleting from Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>(From Column 1 Highway)</u>	<u>(From Column 2 Side)</u>	<u>(From Column 3 Between)</u>	<u>(From Column 4 Times or Days)</u>	<u>(From Column 5 Maximum Period Permitted)</u>
Raglan Avenue	East	A point 61.1 metres north of St. Clair Avenue West and Claxton Boulevard (south roadway)	6:00 a.m. to 12:00 midnight, from the 1st day to the 15th day of each month, April 1st to November 30th, inclusive	60 Min.
Raglan Avenue	West	A point 61.1 metres north of St. Clair Avenue West and Claxton Boulevard (south roadway)	6:00 a.m. to 12:00 midnight, from the 16th day to the last day of each month, April 1st to November 30th, inclusive	60 Min.
Raglan Avenue	East	Maplewood Avenue and Claxton Boulevard (south roadway)	6:00 a.m. to 12:00 midnight, from the 1st day of December to the 31st day of March, inclusive	60 Min.
Raglan Avenue	West	A point 61.1 metres north of St. Clair Avenue West and Maplewood Avenue	6:00 a.m. to 12:00 midnight, from the 1st day of December to the 31st day of March, inclusive	60 Min.

2. That Schedule X (Parking for Restricted Periods) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>(In Column 1 Highway)</u>	<u>(In Column 2 Side)</u>	<u>(In Column 3 Between)</u>	<u>(In Column 4 Times or Days)</u>	<u>(In Column 5 Maximum Period Permitted)</u>
Raglan Avenue	East	Maplewood Avenue and Claxton Boulevard (south roadway)	6:00 a.m. to 6:00 p.m., Mon. to Fri., from Dec. 1 of one year to Mar. 31 of the next following year, inclusive	1 hour
Raglan Avenue	East	A point 61.1 metres north of St. Clair Avenue West and Claxton Boulevard	6:00 a.m. to 6:00 p.m., Mon. to Fri., from the 1st day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive	1 hour
Raglan Avenue	West	A point 61.1 metres north of St. Clair Avenue West and Claxton Boulevard (south roadway)	6:00 a.m. to 6:00 p.m., Mon. to Fri., from the 16th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive	1 hour
Raglan Avenue	West	A point 61.1 metres north of St. Clair Avenue West and Maplewood Avenue	6:00 a.m. to 6:00 p.m., Mon. to Fri., from Dec. 1 of one year to Mar. 31 of the next following year, inclusive	1 hour
