## CITY OF TORONTO

### BY-LAW No. 73-2012

#### To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Raglan Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is hereby amended as follows:

A. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:
