CITY OF TORONTO

BY-LAW No. 165-2012

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, to prohibit standing, stopping or parking during rush hour periods and provide for an increased fixed fine.

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** Chapter 950, Traffic and Parking, of The City of Toronto Municipal Code is amended as follows:
 - A. By inserting a new Subsection B.1 in § 950-101 as follows:

"B.1 As used in §§ 950-405A.1, §§ 950-405D.1 and §§ 950-405G.1 of this Chapter, the following term shall have the meaning indicated:

RUSH HOUR PERIOD – any portion of time falling within the period of 6:00 a.m. to 10:00 a.m. and/or 3:00 p.m. to 7:00 p.m. on any day from Monday to Friday, except Public Holidays."

B. By inserting a new Subsection A.1 in § 950-405 as follows:

"A.1. No parking during rush hour times.

Except where Chapter 903 (Parking for Persons With Disabilities) applies with respect to exempting vehicles displaying an accessible parking permit, and notwithstanding Subsection 950-405A, where official signs prohibiting parking are displayed, no person shall park a vehicle on any highway at the side and between the limits set out in Schedule XIII in § 950-1312 during the portion of the rush hour period set out under Column four (Prohibited Times and/or Days) in Schedule XIII."

- C. By inserting a new Subsection D.1 in § 950-405 as follows:
 - "D.1 No stopping during rush hour times.

Notwithstanding Subsection 950-405D, where official signs prohibiting stopping are displayed, no person shall stop a vehicle on any highway at the side and between the limits set out respectively in Schedule XIV in § 950-1313 during the portion of the rush hour period set out under Column four (Prohibited Times and/or Days) in Schedule XIV, provided that this subsection shall not be deemed to prohibit a taxicab from stopping while actually engaged in loading or unloading passengers on any highway nor a school bus actively engaged in picking up or dropping off school children in a designated school bus loading zone."

- D. By inserting a new Subsection G.1 in § 950-405 as follows:
 - "G.1 No standing during rush hour times.

Notwithstanding Subsection 950-405G, where official signs prohibiting standing are displayed, no person shall stand a vehicle on any highway at the side and between the limits set out respectively in Schedule XVI in § 950-1315 during the portion of the rush hour period set out under Column four (Prohibited Times and/or Days) in Schedule XVI."

E. By inserting in the Table to Subsection 950-1201A in numerical order the following:

"§ 950-405A.1	\$150.00
§ 950-405D.1	\$150.00
§ 950-405G.1	\$150.00"

2. This by-law shall come into effect 30 days after approval of the first set fine order for City of Toronto Municipal Code Chapter 950 offences subsequent to the enactment of this by-law.
