**CITY OF TORONTO**

**BY-LAW No. 190-2012**

**To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding St. Clair Avenue West.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures where they occur opposite each other in Columns 1, 2, 3, and 4 of the said Schedule:

St. Clair Avenue West	North	A point 60 metres east of Avenue Road and a point 30.5 metres east of Avenue Road	Anytime

2. Schedule IX (No Stopping) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures:

St. Clair Avenue West	North	A point 30.5 metres east of Avenue Road and a point 53 metres west of Avenue Road	Anytime
