BY-LAW No. 279-2012

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Balmuto Street.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is hereby amended as follows:

A. By inserting in Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Balmuto Street	West	Between a point 25.5 metres south of Bloor Street West and a point 11.5 metres further south	Anytime

B. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Balmuto Street	West	Bloor Street West and a point 35 metres south	Anytime
Balmuto Street	West	A point 35 metres south of Bloor Street West and a point 77 metres further south	3:30 p.m. to 6:30 p.m., Mon. to Fri.
Balmuto Street	West	Charles Street West and a point 112 metres south of Bloor Street West	Anytime

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

Balmuto Street	West	Bloor Street West and a point 25.5 metres south	Anytime
Balmuto Street	West	Charles Street West and a point 113 metres south of Bloor Street West	Anytime

D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:
