BY-LAW No. 292-2012

To amend By-law No. 2958-94 of the former City of York, being a By-law "To regulate traffic on City of York Roads", regarding Tweedsmuir Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. That Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, be further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Tweedsmuir Avenue	West	A point 30.5 metres north of St. Clair Avenue West and a point 83.5 metres north thereof	Anytime

2. That Schedule IX (No Stopping) of former City of York By-law No. 2958-94, as amended, be further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Tweedsmuir Avenue	West	A point 66.0 metres north of St. Clair Avenue West and a point 35.0 metres north thereof	8:00 a.m. to 6:00 p.m., Monday to Friday

3. That Schedule IX (No Stopping) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Tweedsmuir Avenue	West	A point 83.5 metres north of St. Clair Avenue West and a point 17.5 metres further north	8:00 a.m. to 6:00 p.m., Mon. to Fri.

4. That Schedule X (Parking for Restricted Periods) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3, 4 and 5 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times or Days)	(In Column 5 Maximum Period Permitted)
Tweedsmuir Avenue	West	A point 66 metres north of St. Clair Avenue West and a point 17.5 metres further north	8:00 a.m. to 9:00 a.m. and 3:15 p.m. to 3:45 p.m., Mon. to Fri.	10 mins.

5. That Schedule XI (No Standing) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Tweedsmuir Avenue	West	A point 33 metres north of St. Clair Avenue West and a point 15 metres further north	4:00 p.m. to 7:00 p.m., Sat. and 7:00 a.m. to 4:00 p.m., Sun.
