BY-LAW No. 298-2012

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Bond Street and Gould Street.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Gould Street	North	A point 35.3 metres west of Church Street and a point 42 metres further west	6:00 p.m. of one day to 7:00 a.m. of the next following day, Mon. to Fri.; Anytime Sat. and Sun.
