BY-LAW No. 305-2012

To amend further By-law No. 196, a by-law "To restrict the speed of motor vehicles", being a by-law of the former Borough of East York, respecting Barfield Avenue, Derwyn Road, Dieppe Road, Donmore Avenue, Durant Avenue, Frankdale Avenue, Inwood Avenue, Judith Drive, Kimbourne Avenue, Linsmore Crescent, McKayfield Road, Milton Road, Monarch Park Avenue, Northridge Avenue, Roosevelt Road and St. Hubert Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. The Schedule to By-law No. 196, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting the following in Columns 1, 2 and 3 of the said Schedule in alphabetical order by highway name:
