BY-LAW No. 458-2012

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting St. Helen's Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is hereby amended as follows:
