BY-LAW No. 572-2012

To amend further By-law No. 23503 of the former City of Scarborough, respecting the regulation of traffic on Kenmark Boulevard.

The Scarborough Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by striking out the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:

(From Column 1) Highway	(From Column 2) Side	(From Column 3) From	To	(From Column 4) Times or Days
Kenmark Boulevard	Both	Kennedy Road	Chevron Crescent	7:00 a.m. To 6:00 p.m. Monday To Friday

2. Schedule IX (No Stopping) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3, and 4 of the said Schedule:

Kenmark Boulevard	North	A point 24 metres east of Kennedy Road	A point 184 metres further east	8:00 a.m. to 4:00 p.m. Monday to Friday, except July, August and Public Holidays

3. Schedule X (Parking for Restricted Periods) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3, 4 and 5 of the said Schedule:

4. Schedule XI (No Standing) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3, 4 and 5 of the said Schedule:

Kenmark Boulevard	North	Kennedy Road	A point 24 metres further east	Anytime
Kenmark Boulevard	South	Kennedy Road	A point 20 metres further east	Anytime
Kenmark Boulevard	South	A point 130 metres east of Kennedy Road	A point 30 metres further east	8:00 a.m. to 4:00 p.m. Monday to Friday, except July, August and Public Holidays
