BY-LAW No. 587-2012

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Gladstone Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:
