## CITY OF TORONTO

### BY-LAW No. 642-2012

#### To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Queens Quay West.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
