BY-LAW No. 643-2012

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Queens Quay West.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is hereby amended as follows:
