BY-LAW No. 755-2012

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Victor Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is hereby amended as follows:
 - A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

Victor Avenue	South	Howland Road and Carlaw Avenue	8:00 a.m. of the first day of each month to 8:00 a.m. of the 16th day of each month, from Apr. 1 to Nov. 30, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:
