BY-LAW No. 793-2012

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Rivalda Road.

WHEREAS at its meeting of November 29, 30 and December 1, 2011, City Council adopted By-law No. 1409-2011 to consolidate and incorporate provisions to regulate traffic and parking within the City of Toronto; and

WHEREAS By-law No. 1409-2011, in error, did not include amendments adopted by City Council on April 15 and 16, 2004 in connection with Toronto West Community Council Report 3, Clause 10, entitled "Parking and Stopping Prohibitions on Rivalda Road (Ward 7 – York West)" and related By-law No. 276-2004; and

WHEREAS the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is hereby amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Rivalda Road	East	Sheppard Avenue West and the north end of Rivalda Road	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Rivalda Road	East	A point 164 metres north of Sheppard Avenue West and the north end of Rivalda Road	Anytime

Rivalda Road	West	A point 100 metres north of Bradstock Road and a point 200 metres further north	Anytime

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

Rivalda Road	Both	Sheppard Avenue West and a point 164 metres north	Anytime
