## CITY OF TORONTO

### BY-LAW No. 862-2012

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Beecroft Road, Churchill Avenue, Eglinton Avenue, Elmhurst Avenue, Finch Avenue West, Kempford Boulevard and Poyntz Avenue.**

The North York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is hereby amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

Beecroft Road	Both	Finch Avenue West and Kempford Boulevard	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

Beecroft Road	East	A point 170 metres north of Park Home Avenue and Finch Avenue West	Anytime
Beecroft Road	West	A point 205 metres north of Park Home Avenue and Finch Avenue West	Anytime

C. By inserting in Schedule XIX (One-Way Traffic Lanes) in § 950-1318, the following in alphabetical order by street name:

Beecroft Road	Finch Avenue West and a point 30 metres south	Easterly Northbound	Anytime	Northbound right-turning
