**CITY OF TORONTO**

**BY-LAW No. 898-2012**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Westminster Avenue.**

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
