BY-LAW No. 927-2012

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Dovercourt Road and Sudbury Street.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule IV (Stop Intersections) in § 400-57, the following in alphabetical order by street name:

| Sudbury Street and Dovercourt Road | Sudbury Street (eastbound and northbound) |

| Sudbury Street | South | Dovercourt Road and Lisgar Street | 8:00 a.m. to 6:00 p.m., each Thursday, from Apr. 1 to Nov. 30, inclusive | 1 hour |

F. By deleting from Schedule XXXIX (Designated On-Street Loading Zones for Disabled Person parking Permit Holders) in § 400-92, the following in alphabetical order by street name:
