BY-LAW No. 962-2012

To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Kipling Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures:

2. Schedule X (Parking for Restricted Periods) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures:

Kipling Avenue (M.T. 3)	East	Birmingham Street and New Toronto Street	Anytime	60 Minutes
