BY-LAW No. 966-2012

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking,
respecting St. Clair Avenue East.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is hereby amended as follows:

A. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
St. Clair Avenue East	South	Kingston Road and Santa Monica Boulevard	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
St. Clair Avenue East	South	A point 65 metres east of Santamonica Boulevard and a point 45 metres further east	8:00 a.m. to 6:00 p.m., Mon. to Fri.
St. Clair Avenue East	South	Kingston Road and a point 110 metres east of Santamonica Boulevard	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays
St. Clair Avenue East	South	Santamonica Boulevard and a point 45 metres east	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

C. By deleting from Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

St. Clair Avenue East	South	A point 50 metres east of Santamonica Boulevard and a point 39 metres further east	8:00 a.m. to 5:00 p.m.

D. By inserting in Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
St. Clair Avenue East	South	A point 65 metres east of Santamonica Boulevard and a point 45 metres further east	8:00 a.m. to 6:00 p.m., Mon. to Fri.
