BY-LAW No. 1052-2012

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Scollard Street.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Scollard Street	Hazelton Avenue and a point 89.5 metres west of Bay Street	Anytime	Westbound

B. By inserting in Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Scollard Street	Hazelton Avenue and Bay Street	Anytime	Westbound

C. By deleting from Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

Scollard Street	Both	Bay Street and a point 89.5 metres west	Anytime

D. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

Scollard Street	South	Bay Street and a point 47 metres east	Anytime

E. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Scollard Street	South	A point 89.7 metres west of Bay Street and a point 5.5 metres further west	Anytime

F. By inserting in Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Scollard Street	South	A point 64.5 metres west of Bay Street and a point 5.5 metres further west	Anytime
