## CITY OF TORONTO

## BY-LAW No. 1057-2012

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, and to amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, to provide for on-street electric vehicle parking at charging stations.

WHEREAS on December 1, 2011, City Council enacted By-law No. 1409-2011, a By-law "To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, to consolidate and incorporate provisions to regulate traffic and parking within the City of Toronto"; and

WHEREAS City Council, at its meeting on July 11, 12 and 13, 2012, adopted, as amended, Public Works and Infrastructure Committee Item 16.4, thereby adopting amendments to City of Toronto Municipal Code Chapter 950, Traffic and Parking, as enacted by By-law No. 1409-2011, as further amended, and adopting amendments to City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. Chapter 950, Traffic and Parking, of The Municipal Code of the City of Toronto is amended as follows:
  - A. By inserting in § 950-101B a new definition of "Electric Vehicle" as follows:

"ELECTRIC VEHICLE – A vehicle that has an electric motor that can be powered by drawing current from rechargeable storage batteries or other portable electrical energy storage devices, includes a plug-in hybrid vehicle, and for the purposes of recharging its batteries is equipped to receive a Level 2 SAE J1772 Conductive Charge Coupler (ie. Level 2 charging capability)."

- B. By inserting a new subsection I in § 950-400 as follows:
  - "I. Where authorized signs to that effect are displayed, no person shall park a vehicle on any highway at the side and between the limits set out in Schedule XLIV in § 950-1343 during the times and/or days set out in Schedule XLIV unless the vehicle is an Electric Vehicle and the Electric Vehicle is actively connected to the electric vehicle charging station and the Electric Vehicle is not parked for a longer period than that set out in Schedule XLIV."
- C. By inserting in the Table to § 950-1201A in numerical order the following:

D. By inserting in Article XIII in numerical order the following:

## "§ 950-1343. Schedule XLIV: Electric Vehicle Charging Station Parking"

- **2.** Chapter 903, Parking for Persons with Disabilities, of The City of Toronto Municipal Code is amended as follows:
  - A. By inserting a new subsection (8) in § 903-6B as follows:
    - "(8) In electric vehicle charging station parking listed in Schedule XLIV to City of Toronto Municipal Code Chapter 950, Traffic and Parking."
- 3. Sections 1 and 2 of this by-law shall come into effect the first Thursday following 45 days after approval of the first set fine order for City of Toronto Municipal Code Chapter 950, Traffic and Parking, subsequent to the enactment of this by-law.
