BY-LAW No. 1105-2012

To amend By-law No. 196-84 of the former City of York, being a By-law "To regulate traffic on City of York Roads", regarding Avon Crescent.

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. That Schedule VIII (No Parking) of former City of York By-law No. 196-84, as amended, be further amended by deleting from Columns 1 and 2 of the said Schedule the following:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Avon Crescent	North	Avon Avenue and Weston Road	Anytime
Avon Crescent	South	Avon Avenue and a point 24 metres west	Anytime
Avon Crescent	South	A point 46 metres west of Avon Avenue and Weston Road	Anytime

2. That Schedule VIII (No Parking) of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1 and 2 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Avon Crescent	North	Avon Avenue and a point 24 metres west	Anytime
Avon Crescent	North	A point 46 metres west of Avon Avenue and Weston Road	Anytime
Avon Crescent	South	Avon Avenue and Weston Road	Anytime

3. That Schedule IX (No Stopping) of former City of York By-law No. 196-84, as amended, be further amended by deleting from Columns 1 and 2 of the said Schedule the following:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Avon Crescent	South	A point 24 metres west of Avon Avenue and a point 22 metres further west	Anytime

4. That Schedule IX (No Stopping) of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1 and 2 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Avon Crescent	North	A point 24 metres west of Avon Avenue and a point 22 metres further west	Anytime
