BY-LAW No. 1109-2012

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Fieldway Road.

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is hereby amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Fieldway Road	North	Munster Avenue and Green Lanes	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Fieldway Road	North	Munster Avenue and a point opposite the west side of Carysfort Road	Anytime
Fieldway Road	North	A point 67 metres east of a point opposite the west side of Carysfort Road and Green Lanes	Anytime

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Fieldway Road	North	A point opposite the west side of Carysfort Road and a point 67 metres further east	Anytime

D. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Fieldway Road	Both	Green Lanes and Allerton Road	3:00 p.m. to 5:00 p.m. Mon. to Fri.

E. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Fieldway Road	North	Allerton Road and a point opposite the west side of Carysfort Road	3:00 p.m. to 5:00 p.m. Mon. to Fri.
Fieldway Road	North	A point 67 metres east of a point opposite the west side of Carysfort Road and Green Lanes	3:00 p.m. to 5:00 p.m. Mon. to Fri.
Fieldway Road	South	Allerton Road and Green Lanes	3:00 p.m. to 5:00 p.m. Mon. to Fri.

2. This By-law shall be effective commencing July 1, 2012.
