CITY OF TORONTO

BY-LAW No. 1110-2012

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include The Queensway Business Improvement Area and to establish a Board of Management for The Queensway Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 995-2012, designated an area along The Queensway from Royal York to Kipling Avenue as a business improvement area under Municipal Code Chapter 19, Business Improvement Areas; and

WHEREAS Etobicoke York Community Council has established a board of management for The Queensway Business Improvement Area, and appointed members to The Queensway Business Improvement Area Board of Management for a term expiring on November 30, 2014, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include The Queensway Business Improvement Area Board of Management;

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A, Boards of Management is amended by adding The Queensway Board of Management as set out in Schedule A attached; and
 - B. Schedule A, Maps is amended by adding the attached maps of The Queensway Business Improvement Area.
2. A Board of Management for The Queensway Business Improvement Area is hereby established.



MAP 1 of 3**




