BY-LAW No. 1129-2012

To amend By-law No. 2958-94 of the former City of York, being a By-law "To regulate traffic on City of York Roads", regarding Westmount Avenue.

The North York Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, is hereby further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Westmount Avenue	East	Rogers Road and Amherst Avenue	from the 16 th day of each month to the last day of each month, April 1 st to November 30 th , inclusive
Westmount Avenue	West	Rogers Road and Amherst Avenue	from the 1 st day of each month to the 15 th day of each month, April 1 st to November 30 th , inclusive

2. Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, is hereby further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Westmount Avenue	East	Genessee Avenue and Rogers Road	From the 16 th day of each month to the last day of each month, Apr. 1 st to Nov. 30 th , inclusive
Westmount Avenue	West	Genessee Avenue and Rogers Road	From the 1 st day of each month to the 15 th day of each month, Apr. 1 st to Nov. 30 th , inclusive
Westmount Avenue	East	Martin Street and Amherst Avenue	From the 16 th day of each month to the last day of each month, Apr. 1 st to Nov. 30 th , inclusive
Westmount Avenue	West	Martin Street and Amherst Avenue	From the 1 st day of each month to the 15 th day of each month, Apr. 1 st to Nov. 30 th , inclusive
Westmount Avenue	East	Martin Street and Genessee Avenue	Anytime, from Nov. 30 th of one year to Apr. 1 st of the next following year, inclusive
