BY-LAW No. 1131-2012

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Westmount Avenue.

The North York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is hereby amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Westmount Avenue	East	Rogers Road and Amherst Avenue	From the 16 th day of each month to the last day of each month, Apr. 1 to Nov. 30, inclusive
Westmount Avenue	West	Rogers Road and Amherst Avenue	From the 1 st day of each month to the 15 th day of each month, Apr. 1 to Nov. 30, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Westmount Avenue	East	Genessee Avenue and Rogers Road	From the 16 th day of each month to the last day of each month, Apr. 1 to Nov. 30, inclusive

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Westmount Avenue	West	Genessee Avenue and Rogers Road	From the 1 st day of each month to the 15 th day of each month, Apr. 1 to Nov. 30, inclusive
Westmount Avenue	East	Martin Street and Amherst Avenue	From the 16 th day of each month to the last day of each month, Apr. 1 to Nov. 30, inclusive
Westmount Avenue	West	Martin Street and Amherst Avenue	From the 1 st day of each month to the 15 th day of each month, Apr. 1 to Nov. 30, inclusive
Westmount Avenue	East	Martin Street and Genessee Avenue	Anytime, from Nov. 30 of one year to Apr. 1 of the next following year, inclusive
