## CITY OF TORONTO

### BY-LAW No. 1142-2012

**To amend further By-law No. 23503 of the former City of Scarborough, respecting the regulation of traffic on Bamblett Drive, Belanger Crescent, Bell Estate Road, Dairy Drive, Ethel Bell Terrace and various other streets.**

The Scarborough Community Council HEREBY ENACTS as follows:

1. Schedule XI (No Standing) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:
