BY-LAW No. 1143-2012

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bamblett Drive, Belanger Crescent, Bell Estate Road, Dairy Drive, Edhouse Avenue, Ethel Bell Terrace and various other streets.

The Scarborough Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is hereby amended as follows:
 - A. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:
