### BY-LAW No. 1178-2012

#### To amend City of Toronto Municipal Code Chapter 925, Permit Parking, regarding Tichester Road and Heath Street West.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 925, Permit Parking, is amended as follows:

A. By deleting from Schedule A (Permit Parking), the following in alphabetical order by street name:
