BY-LAW No. 1195-2012

To amend By-law No. 2958-94 of the former City of York, being a By-law "To regulate traffic on City of York Roads", regarding Arlington Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, is hereby further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Arlington Avenue	East	A point 210 metres south of Durham Avenue and Durham Avenue	Anytime

2. Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, is hereby further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Arlington Avenue	East	Durham Avenue and a point 20 metres south	Anytime
Arlington Avenue	East	A point 20 metres south of Durham Avenue and a point 29 metres further south	12:00 a.m. to 7:45 a.m., 9:00 a.m. to 3:00 p.m. and 4:00 p.m. to 12:00 a.m., Mon. to Fri.; Anytime, Sat. and Sun.
Arlington Avenue	East	A point 49 metres south of Durham Avenue and a point 16.5 metres further south	Anytime

3. Schedule X (Parking for Restricted Periods) of former City of York By-law No. 2958-94, as amended, is hereby further amended by inserting in Columns 1, 2, 3, 4 and 5 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times or Days)	(In Column 5 Maximum Period Permitted)
Arlington Avenue	East	A point 20 metres south of Durham Avenue and a point 29 metres further south	7:45 a.m. to 9:00 a.m. and 3:00 p.m. and 4:00 p.m. Mon. to Fri.	10 mins.
Arlington Avenue	East	A point 65.5 metres south of Durham Avenue and a point 29 metres further south	7:45 a.m. to 9:00 a.m. and 3:00 p.m. and 4:00 p.m. Mon. to Fri.	10 mins.
