BY-LAW No. 1197-2012

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Ed Mirvish Way, Elizabeth Street and Wellington Street West.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Ed Mirvish Way	East	King Street West and Pearl Street	Anytime
Wellington Street West	South	Clarence Square and University Avenue	Anytime

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Ed Mirvish Way	East	King Street West and a point 24 metres north	Anytime
Ed Mirvish Way	East	A point 35 metres north of King Street West and Pearl Street	Anytime
Wellington Street West	South	Clarence Square and a point 37 metres east	Anytime
Wellington Street West	South	A point 48 metres east of Clarence Square and University Avenue	Anytime

C. By deleting from Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

Wellington Street West	South	Clarence Square and a point 80 metres west of Blue Jays Way	7:30 a.m. to 9:30 a.m., Mon. to Fri., except public holidays

D. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

Wellington Street West	South	Clarence Square and a point 37 metres east	7:30 a.m. to 9:30 a.m., Mon. to Fri., except public holidays
Wellington Street West	South	A point 48 metres east of Clarence Square and a point 80 metres west of Blue Jays Way	7:30 a.m. to 9:30 a.m., Mon. to Fri., except public holidays

E. By inserting in Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Parking)	(In Column 3 Between)	(In Column 4 Times or Days)	(In Column 5 Maximum Period Permitted)
Ed Mirvish Way	East	A point 24 metres north of King Street West and a point 11 metres further north	Anytime	3 hours (EV Charging Vehicles only)
Elizabeth Street	East	A point 9 metres south of Foster Place and a point 5.5 metres further south	Anytime	3 hours (EV Charging Vehicles only)
