BY-LAW No. 1365-2012

To amend further By-law No. 23503 of the former City of Scarborough, respecting the regulation of traffic on Valparaiso Avenue and Hollyhedge Drive.

The Scarborough Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by striking out the following words and figures from Columns 1, 2, 3 and 4 of the said Schedule:
