BY-LAW No. 1382-2012

To amend City of Toronto Municipal Code Chapter 925, Permit Parking, regarding Heath Street West and Tichester Road.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 925, Permit Parking, is amended as follows:

A. By deleting from Schedule A (Permit Parking), the following in alphabetical order by street name:

Heath Street West	Even	Walmer Road to east limit	All times	12:00 midnight to 6:00 a.m.
Heath Street West	Odd	Tichester Road to Tweedsmuir Avenue	All times	12:00 midnight to 6:00 a.m.
Heath Street West	Odd	Tweedsmuir Avenue to Walmer Road	All times	12:00 midnight to 6:00 a.m.
Tichester Road	Even	Bathurst Street to Heath Street West	All times	12:00 midnight to 6:00 a.m.

B. By inserting in Schedule A (Permit Parking), the following in alphabetical order by street name:

Heath Street West	Even	From Walmer Road to a point 41 metres west of Spadina Road	All times	11:00 p.m. to 8:00 a.m.
Heath Street West	Odd	From Tichester Road to a point 65.3 metres west of Tweedsmuir Avenue	All times	11:00 p.m. to 8:00 a.m.
