BY-LAW No. 1386-2012

To amend By-law No. 196-84 of the former City of York, being a By-law "To regulate traffic on City of York Roads", regarding Heath Street West.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of former City of York By-law No. 196-84, as amended, is hereby further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Heath Street West	South	Walmer Road and a point 41 metres west of Spadina Road	Anytime

2. Schedule VIII (No Parking) of former City of York By-law No. 196-84, as amended, is hereby further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Heath Street West	North	Walmer Road and a point 41 metres west of Spadina Road	Anytime
Heath Street West	South	Walmer Road and Spadina Road	Anytime

3. Schedule X (Parking for Restricted Periods) of former City of York By-law No. 196-84, as amended, is hereby further amended by deleting from Columns 1, 2, 3, 4 and 5 of the said Schedule the following:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times or Days)	(From Column 5 Maximum Period Permitted)
Heath Street West	South	Tweedsmuir Avenue and a point 15 metres west of Walmer Road	9:00 a.m. to 9:00 p.m., Monday to Friday	60 Min.
Heath Street West	South	A point 65.3 metres west of Tweedsmuir Avenue and Tichester Road	8:00 a.m. to 6:00 p.m., Monday to Saturday	3 Hrs.

4. Schedule X (Parking for Restricted Periods) of former City of York By-law No. 196-84, as amended, is hereby further amended by inserting in Columns 1, 2, 3, 4 and 5 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times or Days)	(In Column 5 Maximum Period Permitted)
Heath Street West	South	Tweedsmuir Avenue and a point 26 metres west of Walmer Road	9:00 a.m. to 9:00 p.m., Mon. to Fri.	1 hour
