**CITY OF TORONTO**

**BY-LAW No. 1422-2012**

**To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Avenue Road.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Avenue Road (M.T. 25)	East	Bloor Street West and a point 293 metres north of Yorkville Avenue	Anytime

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Avenue Road	East	Bloor Street West and Cumberland Street	Anytime
Avenue Road	East	Yorkville Avenue and a point 293 metres north	Anytime

2. Schedule IX (No Stopping) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Avenue Road (M.T. 25)	East	Bloor Street West and a point 158 metres north of Yorkville Avenue	7:30 a.m. to 9:30 p.m. and 3:30 p.m. to 6:30 p.m. Monday to Friday, except Public Holidays

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Avenue Road	East	Bloor Street West and Cumberland Street	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m., Mon. to Fri. except public holidays
Avenue Road	East	Cumberland Street and Yorkville Avenue	Anytime
Avenue Road	East	Yorkville Avenue and a point 158 metres north	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m., Mon. to Fri. except public holidays

**3.** This By-law shall be effective November 1, 2012.
