BY-LAW No. 1473-2012

To amend By-law No. 2958-94 of the former City of York, being a By-law "To regulate traffic on City of York Roads", regarding Northcliffe Boulevard.

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, is hereby further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Northcliffe Boulevard	West	A point 61.2 metres north of St. Clair Avenue West and a point 82.7 metres north of St Clair Avenue West	9:30 a.m. to 11:30 a.m., 1:00 p.m. to 3:30 p.m. and 6:00 p.m. of one day to 7:30 a.m. of the next following day, Mon. to Fri.; Anytime Sat. and Sun.

2. Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, is hereby further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Northcliffe Boulevard	West	A point 15 metres north of St. Clair Avenue West and a point 67.7 metres further north	9:30 a.m. to 10:30 a.m., 1:00 p.m. to 3:00 p.m. and 6:00 p.m. of one day to 7:30 a.m. of the next following day, Mon. to Fri.; Anytime Sat. and Sun.

3. Schedule X (Parking for Restricted Periods) of former City of York By-law No. 2958-94, as amended, is hereby further amended by deleting from Columns 1, 2, 3, 4 and 5 of the said Schedule the following:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times or Days)	(From Column 5 Maximum Period Permitted)
Northcliffe Boulevard	West	A point 61.2 metres north of St. Clair Avenue West and a point 82.7 metres north of St. Clair Avenue West	7:30 a.m. to 9:30 a.m., 11:30 p.m. to 1:00 p.m., and 3:30 p.m. to 6:00 p.m., Mon. to Fri.	10 mins.

4. Schedule X (Parking for Restricted Periods) of former City of York By-law No. 2958-94, as amended, is hereby further amended by inserting in Columns 1, 2, 3, 4 and 5 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times or Days)	(In Column 5 Maximum Period Permitted)
Northcliffe Boulevard	West	A point 15 metres north of St. Clair Avenue West and a point 67.7 metres north of St. Clair Avenue West	7:30 a.m. to 9:30 a.m., 10:30 a.m. to 1:00 p.m., and 3:00 p.m. to 6:00 p.m., Mon. to Fri.	10 mins.
