### BY-LAW No. 1492-2012

**To amend further By-law No. 92-93, a by-law "To regulate traffic on roads in the Borough of East York", being a by-law of the former Borough of East York, regarding Rumsey Road, Sutherland Avenue and Sutherland Drive.**

The North York Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by striking out the following words and figures where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:
