BY-LAW No. 1527-2012

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Westmoreland Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is hereby amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Westmoreland Avenue	East	Bloor Street West and Shanly Street	16 th day to the last day of each month, from Apr. 1 to Nov. 30
Westmoreland Avenue	East	Bloor Street West and Shanly Street	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Westmoreland Avenue	West	Bloor Street West and Shanly Street	First day to the 15 th day of each month, from Apr. 1 to Nov. 30, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Westmoreland Avenue	East	A point 44.3 metres north of Bloor Street West and Shanly Street	16 th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive; Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Westmoreland Avenue	West	A point 44.3 metres north of Bloor Street West and Shanly Street	First day to the 15 th day of each month, from Apr. 1 to Nov. 30, inclusive

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Westmoreland Avenue	Both	Bloor Street West and a point 44.3 metres north	Anytime
