**CITY OF TORONTO**

**BY-LAW No. 1532-2012**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Clinton Street.**

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Clinton Street	East	A point 107 metres north of College Street and a point 138.5 metres south of Jersey Street	8:30 a.m. to 5:00 p.m., Mon. to Fri.
Clinton Street	West	A point 107 metres north of College Street and Harbord Street	Anytime

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Clinton Street	East	A point 38.6 metres north of College Street and a point 138.5 metres south of Jersey Street	8:30 a.m. to 5:00 p.m., Mon. to Fri.
Clinton Street	West	A point 107 metres north of College Street and a point 24.5 metres further north	Anytime

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Clinton Street	West	A point 131.5 metres north of College Street and a point 33.9 metres north	9:00 a.m. to 11:00 a.m., 1:00 p.m. to 3:00 p.m. 4:30 p.m. 8:30 p.m., Mon. to Fri.; Anytime, Sat and Sun.
Clinton Street	West	A point 165.4 metres north of College Street and Harbord Street	Anytime

C. By inserting in Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times or Days)	(In Column 4 Maximum Period Permitted)
Clinton Street	West	A point 131.5 metres north of College Street and a point 33.9 metres north	8:30 a.m. to 9:00 a.m., 11:00 a.m. to 1:00 p.m. and 3:00 p.m. to 4:30 p.m., Mon. to Fri.	15 mins.

D. By deleting from Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Clinton Street	Both	College Street and a point 107 metres further north	Anytime

E. By inserting in Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Clinton Street	East	College Street and a point 38.6 metres north	Anytime
Clinton Street	West	College Street and a point 107 metres north	Anytime
