**BY-LAW No. 1534-2012**

**To amend By-law No. 196-84 of the former City of York, being a By-law "To regulate traffic on City of York Roads", regarding Claxton Boulevard.**

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of former City of York By-law No. 196-84, as amended, is hereby further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Claxton Boulevard (north roadway)	North	Raglan Avenue and a point 35 metres west of Bathurst Street	7:00 a.m. to 10:00 a.m. Monday to Friday

2. Schedule X (Parking for Restricted Periods) of former City of York By-law No. 196-84, as amended, is hereby further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Claxton Boulevard (north roadway)	North	Raglan Avenue and point 35 metres west of Bathurst Street	10:00 a.m. to 6:00 p.m.	60 Min.
Claxton Boulevard (north roadway)	South	Raglan Avenue and a point 54 metres west of Bathurst Street	10:00 a.m. to 6:00 p.m.	60 Min.

3. Schedule XV (Parking for Restricted Periods) of former City of York By-law No. 196-84, as amended, is hereby further amended by inserting in Columns 1, 2, 3, 4 and 5 of the said Schedule the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Claxton Boulevard (north roadway)	North	Raglan Avenue and a point 35 metres west of Bathurst Street	7:00 a.m. to 6:00 p.m. Mon. to Fri.	1 hour
Claxton Boulevard (north roadway)	South	Raglan Avenue and a point 54 metres west of Bathurst Street	10:00 a.m. to 6:00 p.m. Mon. to Fri.	1 hour
