CITY OF TORONTO

BY-LAW No. 1537-2012

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, Cowan Avenue, Macpherson Avenue, respecting Nanton Avenue, Ritchie Avenue and Westmoreland Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Time or Days) |
|-------------------------|----------------------|---|---|
| Nanton Avenue | West | A point 72 metres north of Dale Avenue and a point 5.5 metres further north | Anytime |
| Westmoreland Avenue | East | A point 71.5 metres south of Dupont Street and a point 5.5 metres further south | Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive; and from the 1 st day to the 15 th day of each month from Apr. 1 to Nov. 30, inclusive |
| Westmoreland Avenue | West | A point 69.5 metres south of Dupont Street and a point 5.5 metres further south | Anytime from the 16 th day to the last day of each month from Apr. 1 to Nov. 30, inclusive |

- B. By inserting in Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Time or Days) |
|-----------------------|--------------------|--|----------------------------|
| Cowan Avenue | West | A point 65.2 metres north of Springhurst Avenue and a point 5.5 metres further north | Anytime |

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Time or Days) |
|-----------------------------|--------------------------|---|----------------------------------|
| Macpherson Avenue | North | A point 94 metres east of Avenue Road and a point 5.5 metres further east | Anytime |
| Macpherson Avenue | South | A point 89 metres east of Avenue Road and a point 5.5 metres further east | Anytime |
| Ritchie Avenue | East | A point 166.4 metres north of Dundas Street West and a point 5.0 metres further north | Anytime |
