BY-LAW No. 1581-2012

**To assume the municipal services located in and on Winner's Circle,
Sarah Ashbridge Avenue being the streets, Blocks 185, 186, 187, 188 and 189
being the Walkway, Laneway "E" and Laneway "F" except Part 1 on 66R18742,
all being on Plan 66M-2332.**

WHEREAS the City has entered into a Subdivision Agreement with EMM Financial Corp. to provide for the public highway and municipal services on Plan 66M-2332 and all affected City Divisions have no objection to the City's intention to assume the municipal services installed pursuant to the Subdivision Agreement;
