BY-LAW No. 1617-2012

To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Adelaide Street West.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Adelaide Street (M.T. 36)	North	Spadina Avenue and a point 30.5 Metres west of John Street	7:30 a.m. to 9:30 a.m. except Saturdays, Sundays and Public Holidays

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Adelaide Street West	North	Spadina Avenue and Widmer Street	7:30 a.m. to 9:30 a.m., Mon. to Fri. except Public Holidays

2. Schedule IX (No Stopping) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Adelaide Street (M.T. 36)	North	A point 30.5 Metres west of John Street and Spadina Avenue	3:30 p.m. to 6:30 p.m. except Saturdays, Sundays and Public Holidays

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Adelaide Street West	North	Widmer Street and a point 30.5 metres west of John Street	Anytime
Adelaide Street West	North	Spadina Avenue and Widmer Street	3:30 p.m. to 6:00 p.m. Mon. to Fri., except Public Holidays

3. Schedule XI (No Standing) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Adelaide Street West	North	Spadina Avenue and a point 30.5 metres west of John Street	2:00 a.m. to 6:00 a.m. Fri. through Mon.

they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Adelaide Street West	North	Widmer Street and Spadina Avenue	2:00 a.m. to 6:00 a.m. Fri. through Mon.

4. This By-law shall be effective commencing December 1, 2012.
