BY-LAW No. 1689-2013

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting the Snow Emergency Terminology to refer to Major Snow Storm Conditions and to delegate the authority to declare and extend a Major Snow Storm Condition to the General Manager of Transportation Services.

Whereas on December 1, 2011, City Council enacted By-law No. 1409-2011, a By-law "To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, to consolidate and incorporate provisions to regulate traffic and parking within the City of Toronto"; and

Whereas City Council, at its meeting of December 16, 17 and 18, 2013, adopted Public Works and Infrastructure Item 27.14, thereby adopting an amendment to City of Toronto Municipal Code Chapter 950, Traffic and Parking, as enacted by By-law No. 1409-2011, as further amended;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from the heading of Section 950-406 the phrase: "snow emergencies" and inserting in lieu thereof the phrase: "major snow storm conditions".
 - B. By deleting from Subsection 950-406A and from Subsection 950-406B the phrase: "an emergency condition" and inserting in lieu thereof the phrase: "a major snow storm condition".
 - C. By inserting in Subsection 950-406C after the word "Mayor" the phrase: "or the General Manager".
 - D. By deleting from Subsection 950-406C the phrase: "an emergency condition" and inserting in lieu thereof the phrase: "a major snow storm condition".
 - E. By deleting from Subsection 950-406C(1) the phrase: "the emergency condition" and inserting in lieu thereof the phrase: "the major snow storm condition".
 - F. By deleting from Subsection 950-406D the phrase: "an emergency condition" and inserting in lieu thereof the phrase: "a major snow storm condition".
 - G. By deleting from Subsection 950-406D the phrase: "an emergency" where it appears after the word "create" and inserting in lieu thereof the phrase: "a major snow storm condition".
 - H. By deleting from Subsection 950-406E the phrase: "the emergency condition" and inserting in lieu thereof the phrase: "the major snow storm condition".

- I. By inserting in Subsection 950-406E after the word "Mayor" the phrase: "or the General Manager".
 - J. By deleting from Subsection 950-406F the phrase: "emergency condition" and inserting in lieu thereof the phrase: "major snow storm condition".
 - K. By deleting from Subsection 950-406F the phrase: "snow emergency" and inserting in lieu thereof the phrase: "major snow storm condition".
 - L. By deleting from Subsection 950-406G the phrase: "period of emergency" and inserting in lieu thereof the phrase: "major snow storm condition".
 - M. By deleting from the heading in Subsection 950-1316A the phrase: "Snow Emergencies" and inserting in lieu thereof the phrase: "Major Snow Storm Conditions".
 - N. By deleting from the heading in Subsection 950-1316B the phrase "Snow Emergencies" and inserting in lieu thereof the phrase: "Major Snow Storm Conditions".
 - O. By deleting from the heading of Schedule XVIIA the phrase: "Snow Emergencies" and inserting in lieu thereof the phrase: "Major Snow Storm Conditions".
 - P. By deleting from the heading of Schedule XVIIB the phrase: "Snow Emergencies" and inserting in lieu thereof the phrase: "Major Snow Storm Conditions".
2. Section 1 of this by-law shall take effect on January 23, 2014.
