CITY OF TORONTO

BY-LAW No. 683-2014

To amend City of Toronto Municipal Code Chapter 441, Fees and Charges, to update the fees and charges for 2015.

Whereas authority is given to Council to adopt by-laws setting fees and charges; and

Whereas Council, at its meeting of December 16, 17 and 18, 2013, harmonized all Solid Waste Management Division rates for Agencies, Boards, Commissions and Divisions, and School Boards, to the Solid Waste Management Division's Commercial rate with the increase to be phased in as follows: beginning January 1, 2014 by 25% of the difference between the Commercial rates and the 2013 rates; beginning January 1, 2015 by 50% of the difference between the Commercial rates and the 2013 rates, beginning January 1, 2016 by 75% of the difference between the Commercial rates and the 2013 rates and beginning January 1, 2017 at 100% of the Commercial rates; and

Whereas it is necessary to update Schedule 1 to Appendix A of Municipal Code Chapter 441, Fees and Charges, to reflect the increases to these fees and charges effective January 1, 2015;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 441, Fees and Charges, Appendix A, Schedule 1 is amended by deleting Reference Numbers 70, 71, 72.1, 72.2, 72.3, 74, 75, 76, 77.1, 77.2, 77.3, 78, 79, 120, 121, 122, and 123 and replacing these with the same Reference Numbers but with the updated fees as shown in Appendix A attached.
2. Municipal Code Chapter 441, Fees and Charges, Appendix A, Schedule 1 is amended by deleting the Fee Description and Fee Basis for Reference Numbers 74 and 78 and replacing these with the same Reference Numbers but with the complete Fee Description and Fee Basis as shown in Appendix A attached.
3. This By-law and all the fees set out in Appendix A of this by-law shall be deemed to come into force on January 1, 2015.
