BY-LAW No. 974-2014

To amend City of Toronto Municipal Code Chapter 910, Parking Machines, respecting Queen Street West.

Whereas City of Toronto Council on July 8, 9, 10 and 11, 2014 adopted MM54.1, moved by Councillor Colle, seconded by Councillor Crawford, entitled "Request to Adjust Pay Parking Machine Hours on Queen Street West between Spadina Avenue and Simcoe Street", to amend the hours of operation of parking machines on both sides of Queen Street West, between Spadina Avenue and Simcoe Street, to be in effect until 9:00 p.m. daily instead of 12:00 midnight, and on July 11, 2014 enacted By-law No. 705-2014 in connection with same; and

Whereas, due to an oversight, By-law No. 705-2014, did not include amendments to existing parking machine entries in Schedule I to Municipal Code Chapter 910, Parking Machines, with respect to the north side of Queen Street West, between Spadina Avenue and Soho Street; and

Whereas Parts 1 and 2 of By-law No. 705-2014 amended Schedule I to Municipal Code Chapter 910, Parking Machines, by reducing parking machine hours of operation from 12:00 midnight to 9:00 p.m. on the north side of Queen Street West, between Soho Street and Simcoe Street, and the south side of Queen Street West, between Spadina Avenue and Simcoe Street, and Section 2 of By-law No. 705-2014 incorrectly inserted entries for 1:00 p.m. to 9:00 p.m. Sundays, with a maximum parking period of 3 hours instead of 6 hours; and

Whereas under Section 169-26 of Municipal Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Council of the City of Toronto enacts:

1. Chapter 910, Parking Machines, is further amended by deleting the following in alphabetical order from Schedule I:
