BY-LAW No. 725-2015

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Rushbrooke Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Rushbrooke Avenue	East	Eastern Avenue and Queen Street East	16th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive
Rushbrooke Avenue	East	Eastern Avenue and Queen Street East	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Rushbrooke Avenue	West	Eastern Avenue and Queen Street East	First day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Rushbrooke Avenue	East	A point 36 metres south of Queen Street East and a point 65 metres further south	Anytime
Rushbrooke Avenue	East	A point 114 metres south of Queen Street East and a point 39 metres further south	Anytime
Rushbrooke Avenue	East	A point 165 metres south of Queen Street East and a point 43.5 metres further south	Anytime

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Rushbrooke Avenue	East	A point 221.5 metres south of Queen Street East and a point 50.5 metres further south	Anytime
Rushbrooke Avenue	East	A point 101 metres south of Queen Street East and a point 13 metres further south	Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Rushbrooke Avenue	East	A point 153 metres south of Queen Street East and a point 12 metres further south	Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Rushbrooke Avenue	East	A point 208.5 metres south of Queen Street East and a point 13 metres further south	Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Rushbrooke Avenue	East	A point 272 metres south of Queen Street East and a point 12 metres further south	Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Rushbrooke Avenue	West	Queen Street East and the first public lane south	Anytime
