CITY OF TORONTO

BY-LAW No. 1323-2015

To amend City of Toronto Municipal Code Chapter 441, Fees and Charges and Chapter 849, Water and Sewage Services and Utility Bill to reflect the new water and wastewater consumption rates to be charged to metered and flat rate consumers and the water and wastewater service fees and charges, to set the water rebate for low-income seniors and low-income disabled persons, and to change the annual volume consumption eligibility criteria for the Block 2 Rate.

Whereas authority is given to Council to pass this by-law pursuant to subsections 8 (1) and (2) and section 259 of the *City of Toronto Act*, 2006(2) and section 259 of the *City of Toronto Act*, 2006; and

Whereas section 259 of the *City of Toronto Act*, 2006 provides that the City may pass by-laws imposing fees or charges on persons for services or activities provided or done by or on behalf of it; and

Whereas at its meeting of December 9 and 10, 2015 City Council approved the water and wastewater consumption rates to be charged to metered and flat rate consumers effective January 1, 2016, increased various water and wastewater service fees and charges effective January 1, 2016 and April 1, 2016, public notice having been given, and approved the water rebate for eligible low-income seniors and disabled persons effective January 1, 2016; and

Whereas at its meeting of December 9 and 10, 2015 City Council authorized that effective January 1, 2016 the Block 2 process use rate for eligible properties in the industrial property tax class be applicable to volume of water consumed over 5,000 cubic metres per year (m³/year), and as such, that the eligibility criteria for the Block 2 Rate be changed to require that an eligible customer must have an annual consumption of over 5,000 m³/year instead of over 6,000 m³/year; and

Whereas Chapter 441 of the City of Toronto Municipal Code is the codified consolidated user fee by-law for the City of Toronto ("Municipal Code Chapter 441"); and

Whereas Chapter 849 of the City of Toronto Municipal Code is the Water and Sewage Services and Utility Bill by-law for the City of Toronto ("Municipal Code Chapter 849"); and

Whereas it is necessary to amend Municipal Code Chapter 441 to reflect the new water and wastewater consumption rates and the water and wastewater service fees and charges authorized by City Council, and to amend Municipal Code Chapter 849 to reflect the water rebate for eligible low-income seniors and disabled persons and to reflect the change to the annual volume consumption eligibility criteria for the Block 2 Rate;

The Council of the City of Toronto enacts:

- 1. Appendix D Schedule 1, Water & Wastewater Consumption Rates, of Chapter 441, Fees and Charges, Ref. No. items 1-46, inclusive, is deleted in its entirety and replaced with Schedule "A" to this By-law.
- 2. Appendix D Schedule 2, Water Services, of Chapter 441, Fees and Charges, Ref. No. items 1-44, inclusive, is deleted in its entirety and replaced with Schedule "B" to this By-law.
- 3. Appendix D Schedule 3, Wastewater Services, of Chapter 441, Fees and Charges, Ref. No. items 1.1-26 inclusive, is deleted in its entirety and replaced with Schedule "C" to this By-law.
- 4. Section 849-14.5D of Chapter 849, Water and Sewage Services and Utility Bill, is amended by deleting "\$0.9584 /per cubic metre" and replacing it with "\$1.035/per cubic metre" so that the section reads as follows:
 - "D. In any year, or eligible portion thereof, the water rebate or credit rate shall be calculated by the difference in the Block 1 Rate and Block 2 Rate, such rates being based on 'paid on or before the due date', applicable for the year or portion thereof in which the water rebate is being applied for, and such water rebate shall be at the rate of \$1.035/per cubic metre, or such other rate in other years as may be determined by City Council from time to time."
- 5. Section 849-14.1. Definitions. and Section 849-15. Definitions. of Chapter 849, Water and Sewage Services and Utility Bill, are amended by deleting in the definitions of the BLOCK 1 RATE and BLOCK 2 RATE all references to "6,000" and replacing them with "5,000" so that the definitions read as follows:
 - BLOCK 1 RATE The water and waste water domestic-use general service rate for all consumers of water, including the first 5,000 cubic metres per year (m³/per year) consumed by industrial users, as set out in Chapter 441, Fees and Charges, Appendix D, Schedule 1, Water & Wastewater Consumption Rates.
 - BLOCK 2 RATE The water and waste water industrial process-use service rate for eligible properties or portions of properties assessed on the annual returned assessment roll in the industrial property tax class and applicable to volume of water consumed over 5,000 cubic metres per year (m3/per year) of such use, as set out in Chapter 441, Fees and Charges, Appendix D, Schedule 1, Water & Wastewater Consumption Rates.
- 6. Section 849-17. Block 2 Rate., of Chapter 849, Water and Sewage Services and Utility Bill, of the City of Toronto Municipal Code is amended by deleting all references to "6,000" and replacing them with "5,000" so that the section reads as follows:
 - The Block 2 Rate, as set out in Chapter 441, Fees and Charges, Appendix D, Schedule 1, Water & Wastewater Consumption Rates, is available to an eligible industrial process water user for a property, or a portion thereof, assessed on the annual returned assessment

roll in the industrial property tax class and is applicable to volume of water consumed over 5,000 cubic metres per year (5,000 m³/per year) of such use. The Block 2 Rate shall be set at a rate representing a 30 per cent reduction form the Block 1 Rate, as set out in Chapter 441, Fees and Charges, Appendix D, Schedule 1, Water & Wastewater Consumption Rates, or at such other rate as determined by City Council from time to time.

- 7. Section 849-18. Eligibility for Block 2 Rate, of Chapter 849, Water and Sewage Services and Utility Bill, is amended by deleting Subsection B in its entirety and replacing it with the following:
 - B. The customer must have an annual water consumption of over 5,000 cubic metres per year (m³/per year).
- **8.** (1) Subject to Subsection (2) below, this by-law comes into force on January 1, 2016.
 - (2) The amendments, as enacted by Section 3 of this By-law related solely to wastewater services fees Ref. No. items 1-1, 1.2, 1.3 and 1.4, come into force on April 1, 2016.
